The objective of the **Project for Human Resource Development Scholarship by Japanese Grant Aid (JDS)** is to support human resources development of the Kingdom of Bhutan, targeting highly capable young government officials, who are expected to be leaders of the country, and to engage in formulating and implementing social and economic development policies after return. In 2018, JDS is newly introduced to the Kingdom of Bhutan.

- Currently engaging in a Japan International Cooperation Agency (JICA)'s Technical Cooperation Projects as a main counterpart
- Currently awarded or scheduled to receive another scholarship
- Has already obtained a master's or higher degree
- Military personnel registered on the active list or person on alternative military service cannot apply for JDS
